<b>Group C</b>	Youth Events: Youth camps, recreational, cultural groups, etc ( <b>Contract required and Proof of Liability Insurance Required</b> )
<b>Group D</b>	All Daycares working out of our schools ( <b>MOU required</b> )
<b>Group E</b>	All Adult Events: recreational, cultural groups, church groups, Gov. Depts., fundraisers, private, commercial, Educational Inst. Etc. ( <b>Contract required and Proof of Liability Insurance Required</b> )
<b>Group F</b>	Reciprocal Groups covered under City or Town Reciprocal Agreements ( <b>Contract required and Proof of Liability Insurance Required</b> )
